Course Objectives: This course will focus on how a psychoanalytically informed clinician thinks and practices, regardless of clinical setting. Unlike Dr. Kudler's theory course, which will follow several texts chronologically, chapter by chapter, the readings for this course will be drawn from a wide variety of sources, including many papers which are now considered to be classics. We will investigate the ways in which psychoanalytic ideas have evolved over the past century, we will spend time exploring major psychoanalytic concepts (i.e. defenses, transference, counter-transference, dynamic unconscious, self, separation-individuation, oedipal dynamics, etc.), and we will highlight the seminal and evocative ideas from the field's most creative psychoanalytic theorists and clinicians. Classes will be taught using common everyday language, and jargon will be kept to a minimum.

Students should purchase a copy of Janet Malcolms's book (see 10-6-08) and may begin reading at any time. Used copies of this are usually widely available.
